

SUMMER ENROLLMENT 2016 PHASE LISTING BY AGENCY

Summer Enrollment is the time for employees to enroll in or make changes to benefits. Each agency is assigned a two-week phase. Retirees and surviving dependents not eligible for Medicare are in Phase 1.

NOTE: Medicare-eligible retirees and their dependents will have enrollment in the fall. All Medicare-eligible retirees will receive their Personal Benefits Enrollment Statements in the fall before their annual enrollment period begins.

The dependent's enrollment period coincides with the member's enrollment period:

- If the retiree is Medicare-eligible and the dependent is not Medicare-eligible, then the dependent's enrollment period is in the fall.
- If the retiree is not Medicare-eligible and the dependent is Medicare-eligible, then the dependent's enrollment period is in the summer during Phase 1.
