

SUMMER ENROLLMENT 2020 PHASE LISTING BY AGENCY

Summer Enrollment is the time for employees to enroll in or make changes to benefits. Each agency is assigned a two-week phase. Retirees and surviving dependents not eligible for Medicare are in Phase 4.

NOTE: Retirees enrolled in Medicare will have enrollment in the fall.

The dependent's enrollment period coincides with the member's enrollment period:

- If the retiree is enrolled in Medicare and the dependent is not, then the dependent's enrollment period is in the fall.
- If the retiree is not eligible for Medicare and the dependent is Medicare-eligible, then the dependent's enrollment period is in the summer.
